

QlikView Remix Policy

A. Terms

- Provided that licensee is current on maintenance and support for its entire QlikView license estate, all standalone QlikView Client Access Licenses and local clients purchased by licensee (and which are subject to a Qlik license agreement) may be remixed at the licensee's option into Qlik Sense Professional Users in accordance with the terms set forth in this Policy.
- 2. Each remix transaction requires execution of a remix certificate with Qlik. Remix transactions are subject to the terms of this Policy and the certificate. Once elected, Qlik Sense Professional Users may not be remixed back to QlikView CALs.
- 3. For licensees holding less than 10 Named User CALs or equivalent prior to any remix transaction, all such QlikView CALs must be remixed in one remix transaction.
- 4. All other remix transactions must be in increments of at least 10 Named User CALs or equivalent.
- 5. Then-current Maintenance Fees remain payable for all licenses held by licensee following remix.
- 6. A licensee is not entitled to a refund of license or maintenance fees in the event the value of the Qlik Sense Professional User is less than the value of the total fees paid for the QlikView CALs.
- 7. Any license restrictions applicable to remixed QlikView CALs (including but not limited to restrictions regarding view only use, limited user group, or limited application quantity) shall also apply to Qlik Sense Professional User licenses following remix.
- 8. Future software products and/or other currently available software products not listed below are specifically excluded from this Remix Policy. In addition, this Remix Policy is not applicable to: (i) core-based licenses, (ii) any licenses granted to an end user under an OEM, MSP or SaaS offering or arrangement, (iii) enterprise licenses which included a right to deploy QlikView licenses across an enterprise during a deployment period or enterprise term, and (iv) QlikView licenses purchases made after July 1, 2017.
- 9. Licensee shall be required to install the Qlik Sense April 2018 release or later version in order to have access to the full entitlements Qlik Professional User licenses, including Qlik DataMarket Essentials, Qlik Web Connectors, and Qlik GeoAnalytics Base.
- 10. Qlik reserves the right to modify or discontinue this policy at its sole discretion.

B. Remix Ratios

The ratios to remix QlikView CALs into Qlik Sense Professional Users and QlikView Test Servers into Qlik Sense Test Sites are set forth below. The conversion and remix rights set forth in this Policy apply only to the QlikView CALs and QlikView Test Servers listed below.

Named User CAL	1 to 1
Document CAL	4 to 1
Session CAL	1 to 11
Usage CAL	15 to 1
Extranet Session CAL	1 to 2

QlikView Test Server Type	Remix Ratio (Qlik Sense Equivalent)
1 QlikView Enterprise Edition Test Server	1 Qlik Sense Test Site with replication
1 QlikView SBE Test Server	1 Qlik Sense Test Site with 5 Qlik Sense Test Professional User licenses
